Document view and preparation Mode – the usage mode of the User profile, within the frame work of which the Additional user has the right to obtain (view) information on the state of the Account, Account balance, transactions in the Account, Account statements, transactional reports, applications, messages and can prepare (no to submit/send) the orders to FINCI for execution of Payment operations and/or prepare (no to submit/send) documents (messages, applications, requests and other relevant documents).

Payment card user Mode – the usage mode of the User profile, within the framework of which the Additional user has the right to obtain (view) information on the state of the payment card, Account number, has the right to freeze, terminate, unfreeze the payment card, obtain (view) information on all payment card data in the User profile (e.g., CVC, PIN code, full payment card number), obtain (view) information on the authorised purchases with the payment card and manage the client’s issued payment card.

The Additional user is obliged to keep confidential information safe.
